I hereby apply for the issue of the above selected card (the "**Card**") and agree to the terms and conditions set out below, the Rules for the use of cards (the "**Rules**") and the Data Protection Policy (the "**Policy**") available at www.isic.cz (the "**Website**"), and I hereby acknowledge that my personal data will be processed as described in this Application form and in the details in the Policy. I agree to transfer my personal data for the purpose of issuing the Card, including regular updating of these data, to GTS ALIVE s.r.o., a company which provides the issuance and administration of the Card.

Personal data processing information

Separate controllers: GTS ALIVE s.r.o., Identification No (IČ): 26193272 ("GTS") and the holder's school. As a data subject, the holder of the Card applies separately to each data controller, the school's contact details and information on processing by the school for the purpose of using the Card at the school are provided by the school at the latest when the application is filed.

Purpose of processing for GTS: performance of the contract for the purpose of issuing the Card, registration of the Card holders, their verification and check (i.e., subsequent verification of the holder's status), enabling the use of discounts/benefits and verification of the eligibility for discounts/benefits, including with the GTS partner (including public transport) and for the purpose of sending information related to the validity of the Card and the use of the Card. Processing is voluntary, but necessary for the issuance and functionality of the Card.

Categories of data processed by GTS: identification and contact details, school and ID card details, details of the holder's status.

Recipients of personal data: ISIC Association, personal data may be transferred outside the EU while ensuring a standard level of protection through Standard Contractual Clauses, see the Policy for details.

Legal basis for processing and legitimate interests of GTS: performance of the contract. Upon termination of use of the Card or withdrawal of consent, GTS retains a limited range of documents in the event of an inspection by a supervisory authority or a complaint by a subject based on a legitimate interest that may be objected to under the terms of the Policy. The Contract may be terminated at any time in accordance with the Policy.

Rights and how to exercise them: the right to access, rectification, erasure, restriction of processing, objection and data portability - all explained in detail in the Policy, including how to exercise the rights and the possibility to lodge a complaint with the Office for Personal Data Protection. The consumer rights, including information obligations, complaint options and supervisory authorities are explained in the Rules.
